A Five-Year Struggle Against Injustice: My Fight Against Wells Fargo and the DOJ

What follows is the text from a letter that I submitted to the Inspector General of the United States Department of Justice. I submitted it yesterday (8/11/2024). It contains a partial overview of the events that have taken place in a now over 5 years long campaign of terror against me.

It is roughly 24 hours total. The length of the content is due to this being a 5 years long criminal investigation. There is a lot to go over. No one who has watched my entire video series or who has looked at all of my evidence has any doubt that what I say has occurred. I have had two



expert Ph.D. psychologists go over my evidence, and they both agree that what I say has occurred, has occurred. One mainly looked at the evidence for the initial crimes. The other looked at that and also the evidence for the cover up. What has occurred is a atrocious campaign of cruelty, crime, and human rights abuses.

The crime spree involved numerous parties. [@WellsFargo](#) was the primary actor and the orchestrator of the initial crimes that took place before [@TheJusticeDept](#) entered the scene and began to sponsor a cover-up. Wells Fargo would continue to play a key role, and the cover-up was also largely executed by [@AtriumHealth](#), with a significant but much lesser role played by [@NovantHealth](#). My letter to the Inspector General Starts on the next line.

In my previous communication, I said the following:

“I told the LA Times Signal Line every single detail about my life. It's all in there and I was fully prepared for every truth of my life and every lie that others have told to be known to the whole world.”

Why is it, that you are so scared of the actual truth of my life becoming known to the public? Why is it, that you are so scared of what are blatant lies being exposed as blatant lies?

It is because you are among the liars. Your cowardice is nothing new. It is characteristic of the liars who came before you, like Wells Fargo, Abbey Best (the fugitive that Bill Vanhoy employed in validating that I am “dangerous”, according to the bullshit narrative you were fed), Kermit Johnson (who I reported to your agency for unspeakable crimes), and a

host of others who have or had something to lose if the truth about me is known.

As you are in contact with the girl (now woman) from my past, I have a message for you to send to her, if she is willing to read it. I would imagine that she is. It is the apology to her, that I have long wished to give. It is a product of many years of reflection. I will leave it at the bottom of this communication.

I will state the obvious, here, which may or may not be so obvious to you. Your use of this woman and your purpose for using her are completely transparent. All of your actions are transparent.

There is a common tie to every action involved in this over 5 years long campaign of terrorism. It's all about Wells Fargo's liability. It's about the liability that I pose to Wells Fargo and minimizing or eliminating that liability. More specifically, it is about the liability that Wells Fargo has created by its conduct towards me. This can be distilled to- it's about Wells Fargo, and the people at Wells Fargo, not having to be responsible for the consequences of their conduct; it's about Wells Fargo being above the law.

Here is a partial inventory of what has occurred, in chronological order:

1) A senior manager at Wells Fargo, widely recognized as incompetent, has my former coworker Jenny con me out of a link to my Facebook profile and "inquire about my past" to a habitual criminal and eventual fugitive. Jenny returns with information that she obtained, which is none of her business, nor Bill's, nor the numerous employees' she shared it with, and my life mutates into hell. This occurred in ~ December 2017.

2) In horrific pain, I ask for a consequences free conversation, for well over a year. Jenny and others were obviously instructed, by Wells Fargo, to not have this conversation at any cost.

I eventually quit Wells Fargo, in June 2018, due to the constant stigmatization and demeaning behavior from other employees. The stigmatization and demeaning behavior begun immediately after Wells Fargo invaded my privacy (through Bill) and was largely due to my having a behavioral health condition, which Jenny had relayed, from Abbey, to Wells Fargo management, senior management, and employees, as “he has been to a mental institution.”

3) In April of 2019, I briefly make a legal threat, out of anger and out of the pain I had felt from my life being destroyed. It was horrific cruelty and completely unfair to me, how I could not have the consequences free conversation that I wanted. I was not yet aware of just how much further my life could be destroyed. This provokes a crime spree from Wells Fargo. The crime spree was elaborate and sophisticated, although it was ultimately a botched job.

4) Wells Fargo initiates a scam in which I am kidnapped. It was a coordinated and ambitious crime, involving numerous players and over a dozen felony counts. In one crime, my constitutional rights were deliberately violated, exposing Wells Fargo’s thug officer for hire to up to life in prison, in the hypothetical scenario that laws mean anything at all when Wells Fargo is involved in breaking them.

5) Within a month of their kidnapping scam backfiring, Wells Fargo decides that Wells Fargo desperately needs a point in its favor. What to do about this? What else. Wells Fargo is going to commit another federal crime, and it’s going to involve Atrium Health in it. Acting under the direction, and under the promised compensation of Wells Fargo, Shirley, from Atrium Health’s finance department attempts to obtain my medical records, from a different hospital, through Medicare fraud.

Wells Fargo seems to think there might be something in those healthcare records that could be beneficial to Wells Fargo, perhaps something that could prejudice the authorities or regulators against me and in Wells Fargo’s favor. Wells Fargo sizes up the situation, and that this crime is the

appropriate thing to do is a no brainer. There is no downside to committing crimes if you are Wells Fargo. It is Wells Fargo's signature arbitrage and a key advantage.

6) This crime also backfires. I catch Shirley in the act, and I seek help from who would become an equally ambitious criminal, Atrium Health. Following my telling Atrium Health of this attempted Medicare fraud, Atrium Health scurries to cover its ass, by committing crimes against me. If Wells Fargo wants my medical information, well then, they'll give it all to them. That's better than Atrium Health paying any consequences for its crimes. Every detail of my life that I had ever disclosed to my healthcare provider was fair game to be turned over to Wells Fargo on a silver platter, in a massive set of HIPAA violations.

7) Characteristically, I catch Atrium Health and Wells Fargo in this crime, and, characteristically, Wells Fargo is not slowed down the least. I know something is up when poor little Jenny starts leaking out things that could have only come from my healthcare provider. Wells Fargo seems to have clearly advised Atrium Health of the situation, that Wells Fargo is above the law, and that anyone who aids Wells Fargo in its crimes will also be above the law.

8) For the next several months, Atrium Health engages fraud, in preparing my healthcare records. Key facts concerning my profound impairment, my disability, and my suffering are omitted. Subtle insinuations that I am suffering from serious mental illness symptoms also begin to be included. While this is happening, Wells Fargo is still on the case, in illegally obtaining my healthcare records from the hospital I stayed at, at age 18. To Wells Fargo, this federal crime is the holy grail, that it must commit and then deliver the evidence of to the authorities and the regulators.

9) After having finally committed the federal crime, that they had been so anxious to accomplish, Wells Fargo delivers my illegally obtained healthcare records to the Justice Department, the Federal Reserve, and



I'm sure other regulators. Wells Fargo gives the authorities and regulators a bullshit narrative, about "seeing signs that I'm dangerous" and "having an obligation to protect people." The Justice Department has not the slightest bit of skepticism for Wells Fargo's claim to have all pervading knowledge of behavioral science.

That an incompetent senior manager of a credit department could spot a "dangerous person" from barely a handful of interactions was completely plausible. This dumbass's purported acumen was also a sufficient retroactive justification for the repeated kidnappings, fraud, HIPAA violations, and violations of my constitutional rights, that had occurred a year or more before Wells Fargo had illegally obtained those healthcare records.

If Wells Fargo self-assigns a moral obligation to commit crimes, well then, they're not really crimes. Equally, if Wells Fargo feels justified in forcing a violation of someone's constitutional rights, then so much for that person's constitutional rights.

It's not "the rule of law" and it's not "the Constitution of the United States shall be the supreme Law of the Land;" it's the rule of the whims, caprices, and demonic impulses of the people at Wells Fargo, as they recklessly destroy my life and any other person's life they wish, to serve their own interests or even just out of pure arrogance. The supreme Law of the Land is the interests of Wells Fargo, which most conspicuously include the right of the people at Wells Fargo to do absolutely as they please.

Having great reverence for the supreme Law of the Land, the people at the Justice Department decide to design a process, for handling this crime spree by Wells Fargo & Wells Fargo's numerous accomplices, that is focused on the comfort and the gratification of the people at Wells Fargo. The emphasis would be on gratifying the people at Wells Fargo's oversized egos and gratifying their sadism.

As time would progress, the people at Wells Fargo would have ample opportunities to mercilessly pound their victim with demeaning abuse. Of the utmost importance was that the people at Wells Fargo pay absolutely no cost for their crimes. To this end, the Justice Department, like Wells Fargo, was completely indifferent to the possibility that I die from the stress of their merciless criminal abuse, i.e. the Justice Department couldn't give a shit less if this bank becomes a murderer right in front of its eyes.

The Federal Reserve was also agreeable with this approach. They issued demeaning remarks to me, when I contacted them. They seemed to share Wells Fargo's penchant for recreational sadism, with their delight in taunting the disabled man who the bank had kidnapped. Participating in Wells Fargo's crimes was a fun time for the Federal Reserve. The people at the Federal Reserve seem to think it's a good fortune to have an unending criminal offender to regulate, because they need some recreation.

10) A key player, in aiding Wells Fargo, Wells Fargo's accomplices, and the Justice Department, would be my own mother. Her motive, for aiding in the creation of fraudulent healthcare records and in criminally motivated civil commitments, was to cover-up horrific child sex abuse that I suffered as a child. The Justice Department and Wells Fargo were delighted to take advantage of this quid pro quo relationship. My mother had initially been procured as a criminal accomplice by Atrium Health, after I was forced to hand over her phone number as a condition of being released from captivity, following the hospital and Wells Fargo having me kidnapped.

In that last sentence, as you read it, did you scoff at the word captivity? Do I seem to you to be making too big a deal out of what happened? I expect a yes on both counts. This is because you trivialize this bank's crimes, and you trivialize the harm that they cause. I was kidnapped, both under the law and in principle, in a scam that was orchestrated by Wells Fargo. I was then confined, against my will, based on this



kidnapping and based on other false pretenses that were ultimately put in place by Wells Fargo. I was profoundly handicapped with PTSD following this and I remain disabled to this day. I am permanently disabled from this bank's crimes.

This bank had me kidnapped. It was a real kidnapping, and your agency isn't doing shit about it. I suffered real and profound harm; just as most kidnapping victims do. This bank is a criminal. It committed crimes against me, and those crimes have destroyed my life. Read this paragraph over and over. Record yourself reading it out loud, and play that recording all day long, every day. This is the reality that you seem to have such trouble with. What are we going to do about a \$1.9 trillion bank that did this to someone and that has the right to kill?

That's the challenge that your agency faces, and distracting yourselves by terrorizing a disabled man isn't going to make it go away.

11) Not knowing that the Justice Department was already involved in crimes against me, I eagerly submitted my revised complaint about the kidnapping and other crimes. It had been revised and greatly lengthened, from the original complaint that I had submitted about 7 months earlier. This was on October 28th, 2020. In the email and attached documents, I offered 3 times to help the Justice Department in any way that I could. You have no mercy for disabled people who offer to help you; you only have affection for corporate criminals who hand deliver you evidence of crimes. That's the disturbing reality that I would eventually find out.

I had been motivated by my illegal hospital stay at Novant Health, to submit my complaint asap. I needed the Justice Department to intervene in the illegal abuse of the mental health system. This would become ironic, in retrospect, as the illegal stay at Novant Health was a crime sponsored by the Justice Department. It also involved Atrium Health and Wells Fargo (who is part of everything). This criminally motivated hospitalization, which was for the purpose of state sponsored

healthcare fraud, was paid for by state Medicaid funds. You'll notice the taboo against Wells Fargo being responsible, in any way, for its own criminal actions. You sent the bill to poor people, effectively. This is just like my illegal imprisonment at Atrium following the kidnapping, which Medicaid funded ultimately paid for.

It was sometime in this vicinity that I reported my ex-friend, Kermit Johnson, to your agency, specifically to the F.B.I. Kermit is a man who had some problems, to put it lightly. It was sometime in my mid to late twenties that it dawned on me, the horror of what had happened with him and a teenage girl when I was at his trailer at age 17. It was about the time that I had that realization, that he had started being a much better person.

When I first knew him, at age 15, he was intensely racist, and he had a penchant for intoxicated girls who were about my age. At that time, he was about 22. I witnessed a lot of disturbing things, in the time I spent with him. My friend Charlie would drive us to his place. I didn't drive, and so wherever Charlie went, I went.

It was in February 2019, that I realized that he was where Abbey got her information about me from. At that time, I could only imagine how hate filled that what she said was. There is something wrong with that man's mind, that causes his every perception of others to be warped with hate. I was happy to no longer be his friend, but I was also very concerned.

His genuine and successful attempt to be a better person, starting back in about 2017, had been interrupted and thwarted a good while before I had submitted my complaint. He had repeated brain surgeries, to treat recurring seizures, and the extracting of so much brain tissue had severely impaired his inhibitions and his self-control. I had also figured out, much later than I should have, that this is a very dangerous man.

With his inhibitions stripped, he had started to reveal an attraction, that he had apparently hidden his entire life, to prepubescent children. I had

contacted some of his old girlfriends and romantic interests and learned of his cruel and ruthless manipulation of them. One of them also confided in me, in early 2020, that he had produced child pornography featuring her, when she was age 16. At that time, he was about 30 and they were dating.

I was scared of what might happen, with his inhibitions almost totally gone and him being in contact with children. At one point, he was dating a woman who had two young daughters. When I realized that my matter would be going to the top of the house, I felt that I had a moral obligation to report him to you. The woman who had dated him when she was 16 years old was extremely happy about this. He had taunted and harassed her and her husband repeatedly. He is an incredibly vengeful and spiteful person. I reported him for his numerous crimes against children, and I included that he had essentially spilled out to me that he wanted to commit another one.

I had months before sent Wells Fargo screenshots of his IMs, in which he was using the n word, calling girls meth whores, saying his ex-romantic interest had HIV, and joking about having sex with a deceased ex-girlfriend. Many months prior to that, I had told Wells Fargo all about him in my chat with Courtney. Some of these new IMs vetted what I had told Courtney. I eventually sent you a copy of his Facebook racism party and more than one detailed explanation of how I knew him and how dangerous a person I had found him to be.

None of this slowed Wells Fargo down in the least in using this man to get information about me. I have absolutely no doubt that your agency has also used him for the same purpose. My felt moral obligation to report him struck no chord in you. You were more concerned with Wells Fargo's moral obligation to commit crimes.

12) Following submitting my complaint, in the second half of December 2017, I have an Australian model sending me IMs on Facebook Messenger. She spoke as if she had romantic intent, and she also made

it clear that she was beholden to me. I could do no wrong, and she profusely apologized for things that could not even remotely be considered an inconvenience. She was open to moving to America to be with me.

I was a broke disabled man. I had a disheveled appearance. There was no reason for a model to act this way with me. It was obvious that this woman was being offered a fortune to be my girlfriend/wife, and it was obvious which conspicuous player in the mix would be paying her that fortune. I thought that the Justice Department was doing something for me. I thought that they were making Wells Fargo get me this girl. It made me very happy, but I would later learn that this whole thing was all about Wells Fargo and not even 1% about me. I learned this after she was cruelly taken away from me.

13) Things quickly don't add up, beginning in January 2021. I begin to be subjected to healthcare fraud. I eventually realize that the Justice Department is sponsoring these ongoing crimes, which were being executed by Atrium Health and Novant Health. I would eventually be subjected to months of merciless criminal abuse and repeated and unending human rights abuses, in this state-sponsored cover-up of Wells Fargo's crimes. Some of what occurred amounted to literal torture.

The parties to this cover-up deliberately defraud the social security administration, to make sure that my disability case is declined. They do this through deliberately falsifying my healthcare records. My life in Charlotte, which meant more than anything to me, eventually collapses, as I am handicapped, suffering profoundly, and unable to make an income.

14) As this is going on, I send unending communications to the Justice Department. A frequent theme is me pleading for my life in humiliation. The people on the other end find utility in my communications. One is that me pleading for my life in humiliation gratifies the egos and the sadism of the people at Wells Fargo. It reaffirms their status as deities,

which I had so offensively called into question by complaining about their unending series of felonies against me.

The need for the people at Wells Fargo to be considered as deities imposes potentially enormous constraints on what outcomes are possible for American citizens and businesses. At no cost, of human life, human suffering, or injustice, will a world in which the people at Wells Fargo are not deities be permitted to exist.

The other utility my cries for help have is that they provide a continuous stream of information to the Justice Department and Wells Fargo. In between my pleas, will be information that can be mined for use. This is information that they can use in planning and executing more crimes against me.

I eventually send thousands of emails to the Justice Department, including hundreds of hours of attached audio recordings, in which I try to reason with the Justice Department and provide arguments in my favor. All of my emails are mined for info, in the same fashion. They are additionally sent to Wells Fargo's legal counsel, to be used in building the strongest legal case possible against me. Of this I am certain. You have also quite possibly quote mined them for use in a propaganda campaign. The Justice Department is on the side of the powerful and seems to think that the powerful can do no wrong.

15) I naïvely think that the Justice Department has decided to give me Justice, as of early to mid-2023. It turned out that the relent in the terror campaign against me was not a good sign, but merely a result of Wells Fargo and the Justice Department not realizing just how powerful my evidence against them is. In this state of naïveté, I send you pictures of my little woman in the Philippines and her brother. You use those to track her down, lie to her about me, and offer her hundreds of thousands of followers for her Facebook blog in exchange for information about me.

Lying about me, behind my back, and deliberately doing everything that you can to prevent me from responding has been a primary tactic of Wells Fargo and the Justice Department.

16) You eventually track down my video series, getting it from people in the media, who you almost certainly lied about me to.

17) You take other criminal actions, that you know and that I don't feel like describing here.

18) You finally get in contact with this girl from my childhood, who I had told you about years ago. I had told you about the instances of inappropriate and potentially abusive behavior that occurred with this girl, when I was aged 12 and 14. I had told you how this girl was a target of such behavior from many boys. I told you how this girl eventually began to be raped, on a daily basis, by her brother, and how that abuse had motivated her to tell about me, as a means of crying out.

I told you how I was the weakling that it was safe to tell about, and that what she wanted was for her parents to figure out what had happened with her brother. I told you how this had all been confirmed with one of her very best friends, who was present at the time she told. I told you how this girl could be influenced, by a dishonest and motivated party, like Wells Fargo, to cast me in a terrible light and make me seem as if I caused profound pain. I told you how I had tried, for many years, to make it right with this girl. I told you how I was going to give her money from any settlement I got from the bank, and that I wanted to apologize to her not just for myself, but for all of those, and there are many, who do not care to say that they are sorry.

In short, I characteristically gave you extremely accurate information, and you characteristically used it for your own purposes, those purposes being lies, deceit, and crime, in service of making sure Wells Fargo, and also yourself, do not face any accountability for your crimes.

You arranged an elaborate scam that went as follows. You have this girl (now woman) post 5 consecutive videos on a music video sharing site where I occasionally watch her sing. In each of these videos, she is wearing a shirt that has been cut in the middle, and she is deliberately leaning forward excessively. All of this is done under your direction. When I log on and see those videos, the My Verizon app on my phone asks for permission to use my camera. This was odd to me. I didn't even have My Verizon app up, but I'd been up all night, and I just clicked to allow.

After the fact, I realize that the My Verizon app has no use for my camera; that it should never ask me for it, and I also see that she has blocked me. This is all done by you. You have attempted to catch me, on camera, ogling at this woman, so as to paint me as some kind of deviant. You have characteristically broken your neck in this scam. There are no measures too extreme for you, in demonizing and terrorizing the kindhearted man who you and this bank have terrorized for now over 5 years. You have literally had people behind the scenes at Verizon and behind the scenes at StarMaker at the same time, to execute this scam.

You can make whatever fruitcake bullshit claim you want, about your motive in doing this, and I'm sure that you will. No matter how hard you break your neck, I can defend my life with complete ease, against such obvious garbage.

Is this another "moral obligation"? For a bank that committed 4 million felonies against its customers and that had me kidnapped for merely asking to have a consequences free conversation, these people seem to have an excess of self-imposed moral obligations. The common elements, that I am seeing, to their "moral obligations" are that they always, without fail, are obligations to do things that serve their own interests, and they seem to fairly consistently be things that violate civil laws, criminal laws, or both, often very egregiously. Most conspicuously absent, among their collection of self-imposed obligations, is a moral obligation to conduct themselves according to what is lawful.

They will claim such an obligation, when it serves their interests, but it's just laughable when you know the facts like I do. For instance, Tim Sloan, when asked a question by a congressperson about potentially offshoring and automating 10s of thousands of jobs, said that he has a responsibility to make sure the company is in existence and profitable.

He says this as if the bank didn't make nearly 20 billion dollars a year while paying onshore, flesh and blood workers for those positions, and as if he didn't lie to his shareholders at a shareholders meeting. He's obligated to follow the law when it serves his interests and when he feels like it. Read between the lines and you'll see that's not really an obligation; it's just an excuse to serve his own interests.

The company did get sued for lying to shareholders, and the judge ordered them to pay \$1 billion. The company elected to pay the \$1 billion judgement, rather than murdering the judge. Shooting a judge dead in broad daylight would create a hell of a PR crisis, and Wells Fargo is scared to death of what the public thinks of their rotten conduct, if and when it is exposed. The effect of this is that the opinion of the public imposes a constraint on the bank's conduct that prevents the bank from murdering a judge.

Outside of that, the people at this bank have no such constraint. They will not self-impose a constraint, in which they are morally obligated to follow any law, and there are precisely 0 people in the government who will impose such a constraint from the outside. This is given that the bank's crimes can't be proven or can be covered up. If it is caught red handed, then it is in the bank's best interest to face consequences, usually in the form of a fine that doesn't faze them for 2 seconds. What we have yet to see is the people at this bank being compelled to behave in a way that doesn't serve their interests, from something other than the opinion of the public or the laws of physics. I'm not holding my breath.

Wells Fargo has a moral obligation to illegally obtain my healthcare records, which create retroactive moral obligations to invade my privacy, have me kidnapped, perpetuate healthcare fraud, and attempt to defraud Medicaid. Now they have a moral obligation to conspire in what is undoubtedly a massive invasion of my privacy. That's your spiel?

You won't frame it that way, or at least that's not what you planned. You want to demonize me, and you want to assign some virtue to yourself, so as to provide cover for your real and obvious motive. I can already hear your fruitcake claim "we have an obligation to protect women and girls..."

Go back over the rest of the numbered list. Is a motivation to protect women and girls what caused you to have me kidnapped, to create fraudulent healthcare records, to buddy up with someone who committed unspeakable crimes against children, rather than prosecute him, to cooperatively engage with someone in crimes to cover-up child sex abuse, and to go out of your way to defraud the social security administration? Is that why you got me an Australian model, who you offered a fortune to be my girlfriend? You see how this doesn't add up? Do you see how your web of lies is increasing untenable?

The common theme here, is me being a liability for Wells Fargo, and Wells Fargo and the Justice Department doing anything and everything they can to get rid of that liability, with a strong bias towards indecency, deceit, cruelty, crime, and human rights abuses. It's about terrorizing me, period.

Kindhearted men like me do not pose a threat to women and girls, whether you have footage of them ogling at one or not. Who poses a threat to women and children are the people who are completely above the law, and whose impunity is enforced by the highest authorities in the land.

It is those people who are permitted to commit every crime in North Carolina General Statutes Chapter 14 and every crime in Title 18 US



Code, including crimes against children. The people in Jeffrey Epstein's black book are in that category, and the people at Wells Fargo are obviously in there with them. It is not surprising, in retrospect, that a class of people who are permitted to rape and abuse women and girls would also be permitted to have people kidnapped and to illegally obtain their healthcare records. Rather than being a surprise, the situation with me has helped to define the lines around that class of people, to more clearly show who is included.

Your agency has said, many, many times, that there are not two different sets of rules for the powerful and the powerless. You have repeatedly espoused your virtues, those you claim to have. For now nearly 4 years, I have needed you to be the people who you claim to be. I have tried to convince you to be those people. I have tried to tap into to some sliver of that in you, as to somehow coax the rest of it out, seeing it that somehow this essence of your values has gone into hiding and just needs brought back out.

A shorter way to say it is that I believed your lies, and now I just believe that you are liars. You are corrupt in every fiber of your being, down to the marrow of your bones, and you are the most despicable and pathetic people I have ever known.

You are the Justice Department. What you offer is in your name. The catch, I have found, is that in your vernacular, the meaning of justice is enforcing the impunity of corporate criminals and knocking the hell out of powerless people. That's you in a nutshell, and all else you do does nothing to subtract from this basic reality.
